A publication entitled 'Development of Horticulture in SAARC Countries' has been published to meet the common interest of the people working in the horticultural sector in the region. A number of books, journals, magazines, and reports on agriculture has been produced and collected during the year. SAIC also procures internationally reputed databases in CD-ROM and is disseminating the information to the relevant corners in the region. A number of video films on latest agricultural technologies from the institutions of the region has been collected and efforts are being made to disseminate them through television programme. Some of this films have been reproduced and exchanged among the interested organizations of member countries. A special bulletin on the current food situation of the SAARC member countries is regularly prepared. In addition to this, a current awareness bulletin is also prepared, comprising the information appearing in different daily news papers and magazines of the SAARC member countries.

Through its different approaches, SAIC is making untiring efforts to keep all those people involved and well informed in the advancement of agriculture in SAARC region.

The professionals and general services staff of the Centre provided the basic material, record and information and I express my appreciation to their contribution made by them in bringing out this annual report.

I express my gratitude and sincere thanks to Dr. M.A. Hamid Miah, Executive Chairman, and Dr. Md. Nurul Alam, Member-Director (P&E), BARC for their constant encouragement and support in various activities of the Centre.

#### The Commencement of SAIC

Cooperation in the field of agriculture, one of the five areas which was primarily identified in the first meeting of SAARC (South Asian Association for Regional Cooperation) Foreign Secretaries in April 1981. The Study Group discussed in details about the possible fields of major cooperation in September 1981. This was followed by the two meetings of Working Group on agriculture held in March and December 1982 which had the mandate of (i) identifying action programme which could be implemented immediately from available funds, (ii) delineating modalities for implementation, coordination and monitoring activities in the short and long term, (iii) providing indicative cost estimates of the identified programmes and their financial implications and finally, (iv) suggesting the modalities of funding.

The SAARC Technical Committee on Agricultural (TCA) underscored the need for a regional information system for promotion of cooperation in the field of agriculture and allied sectors among the member countries and proposed to the SAARC Standing Committee for establishment of an information centre in the field of agriculture in Bangladesh. The Standing Committee approved the proposal in its Sixth Session and sent it to the SAARC Council of Ministers for consideration. The Council of Ministers in its First Session held in Dhaka during 12 to 13 August, 1986 accepted the recommendations of the Standing Committee and declared in the Joint Communiqué that the SAARC Agricultural Information Centre (SAIC) would be established in Dhaka, Bangladesh.

The SAARC Agricultural Information Centre (SAIC) is the first regional institution of SAARC. The Centre started functioning in Dhaka in the premises of Bangladesh Agricultural Research Council (BARC) in January 1989. The objectives and functions determined for SAIC are as follows.

#### **SAIC Objectives**

- (a) Establish regional information network on agricultural and allied discipline
- (b) Identify and document agricultural and pertinent literature including forestry, fisheries, livestock and allied disciplines
- (c) Serve the Agricultural information needs of the member countries
- (d) Promote new and better techniques for handling and dissemination of

- agricultural information
- (e) Collection of information and dissemination of the same in the area of proven agricultural technologies and dissemination of the information on effective farm practices and development as well as introduction of emerging new and frontier technologies

#### **Functions of SAIC**

- (1) Collect information on current agricultural literature, on-going research and development projects, research and development institutions, education and training opportunities and resource persons in agriculture and allied disciplines from the member countries
- (2) Select, analyze and process regional agricultural information useful to regional users
- (3) Provide access to these information for users of the region
- (4) Produce publications of regional importance on agriculture and allied disciplines
- (5) Provide selective dissemination of information, copies of documents, microfiche and video films generated in the region
- (6) Organize and provide training on information and communication sciences to the personnel of member countries
- (7) Function as the regional information centre for South Asia and have access to the international information networks
- (8) Work towards collection of information and dissemination of the same in the area of proven agricultural technologies and dissemination of information on effective farm practices and development as well as introduction of emerging new and frontier technologies.

#### The Administrative Set-up of SAIC

The Governing Board (GB) is the apex body to supervise the functions of SAIC which is composed of eminent personalities in the field of information from each member countries sets down the policy matters, approves the projects, recommends the annual budget estimates, monitors and evaluates the administrative and overall operations of SAIC. The GB is headed by a Chairman designated for a three-years term from the

member countries by alphabetical rotation. The GB meets usually once in a year and may met more frequently if required. A representative of the SAARC Secretariat also attends the GB meeting. The Proceedings of the meeting need to be approved by the Standing Committee and the Council of Ministers.

The Director is the Chief Executive of SAIC in respect of administration, finance, planning, and implementation. He also bears the charges of the Member-Secretary of the SAIC Governing Board.

The Deputy Directors and Professionals perform the professional duties of SAIC and are responsible for functional assignments and activities. Their status and immunities are equivalent to the first Secretaries of the High Commissions/ Embassies of the SAARC member countries situated in Dhaka.

Deputy Directors and Professionals are appointed from the member countries with a fair degree of regional representation. The tenure of services of the Deputy Directors and Professionals is for a period of three years. The GSS are appointed from among the nationals of Bangladesh.

SAIC has four programme divisions, i.e., Information Division, Publication Division, Computer Division, and Library & Reprography Division. Each division is headed by a Deputy Director who is assisted by a Specialist and a number of GSS. The programme of SAIC are undertaken to serve the common requirements of the member countries for mutual benefits. In addition to these divisions, SAIC has also two sections, i.e., (a) Finance, and (b) Support Service Sections. Under direct supervision of the Director, financial and support services activities are taken care of by these two sections.

#### Responsibilities of the Programme Divisions

The Information Division designs and develops information systems and services to meet the information needs of the member countries in the areas of research, technologies, studies etc., covering the field of agriculture and allied discipline. The Division processes repackages and disseminates information collected from all possible sources for expeditious retrieval in the computer as well as in hard copy.

The Computer Division renders its services to all of the divisions in creating databases on agriculture, fisheries, forestry and allied disciplines on regional basis. It preserves all SAIC projects for future updating and revision. Establishment, extension and maintenance of facilities to other divisions for effective and quick exchange of valuable information through modern communication facilities like e-mail and internet are also looked after by this Division.

The Publication Division is entrusted with the responsibility of editing and publishing all outputs of SAIC. The Division has been regularly publishing a quarterly SAIC Newsletter covering latest activities of SAIC and useful technical information relating to agriculture and allied fields.


The major task of the Library Division is procurement and processing of available agricultural information materials. After collection, important published materials are stored in reprographic forms. The Division also envisage to establish exchange programme with other institutions/ libraries for meeting the needs of the agricultural information of the region.

#### **Funding of SAIC**

As host country, Bangladesh provides the capital costs and other infrastuctural facilities, such as accommodation, furniture, equipment etc. The institutional and programme costs are shared by all the member countries according to an approved apportion formula. SAIC budgetary estimates and projects are recommended by the SAIC Governing Board for approval of the Standing Committee consisting of the Secretaries of the Ministry of Foreign Affairs of the member countries. The Standing Committee sanctions the budget and approves project proposals and the Council of Ministers authorizes SAIC for realization of funds from member countries, incurring expenditures and implementing the programmes of activities.

#### **Programmes During the year 2000**

During the year 2000 SAIC undertook and executed the following programmes:



#### **SAIC Newsletter**

SAIC has been publishing a quarterly newsletter entitled, SAIC Newsletter. SAIC Newsletter has been reorganized, made more informative and has been assigned with International Standard Serial Number (ISSN) during the period. SAIC Newsletter contains information on technologies generated in the region on various fields of agriculture, such as crops, fisheries, forestry, livestock etc., besides special news items from the member countries.

The following issues of the Newsletter were published and distributed among the readers in the region during the period: SAIC Newsletter, Vol. 9, No. 2, 3, 4, and SAIC Newsletter, Vol.10, No. 1.

#### Food grain Situation in SAARC countries

SAIC has initiated collection, collation and compilation of relevant data like production, anticipated demands, likely shortfalls, surplus etc. of major food grains of SAARC countries which are being distributed among the concerned organizations in the region as per decision by the SAARC Food Security Reserve Board.


During the period under report, SAIC compiled, processed and distributed the following bulletins to the concerned organizations of the SAARC region:

#### **Compilation of National Papers on Development of Horticulture**

SAIC compiled and published the National Papers on Development of Horticulture in the SAARC Countries during the period under report. The publication contains seven country papers on development of horticulture in the SAARC countries which were presented and discussed at the seventeenth meeting of the SAARC Technical Committee on Agriculture, held in New Delhi, India from 15-17 February 1999. The papers reflected the achievements, adoption and development of technologies,

opportunities for improvement, scope for collaboration and among the SAARC countries and other vital issues to upgrade and development of horticultural sector in the region.



#### **Updating the Directory of Agricultural Periodicals of SAARC Countries**

For collection of data on journals, serials, periodicals etc. in the field of agriculture a large number of relevant organizations in the region have been identified. Request letters along with data collection format have been sent to those organizations for providing the data. A good number of response are being received from these organizations.

#### Annotated Bibliography on Seed Quality, Production and Preservation

Research organizations, academic institutions, NGOs, seed companies etc. concerned with seed quality, production, handling, storage and preservation within the region have been identified for collection of data. Letters were sent to the relevant organizations to make the data available. Identification of other sources for collection of data are also in progress.

#### **Updating the SAIC Mailing List**

The Mailing List of SAIC has been updated for smooth distribution of Newsletter and other SAIC Publications. It was observed that some of the distributed SAIC publications were returned to SAIC along with 'Unclaimed' comment from the postal department. As such, regular correspondence is being made with the relevant organizations in all member countries requesting to inform SAIC regarding their change of addresses to keep SAIC mailing list up to date.

#### **Distribution of SAIC Publications**

SAIC is distributing it's different publications to different agricultural institutions of the SAARC member countries as per the mandate of SAIC. During the year 2000, SAIC Published the book entitled 'Development of Horticulture in the SAARC countries' Annual Report for the year 1999 and four issues of the quarterly SAIC Newsletter. The publications were distributed among the SAARC member countries and also to the international organizations namely, FAO, ISNAR, WARDA, CAB, AVRDC, CIMMYT, IRRI, ICARDA etc. Country-wise distribution of SAIC publications is given below:

#### **Procurement of Databases in CD-ROM**

SAIC has been procuring some world agricultural databases on CD-ROM as a part of building its collection in various forms having access to regional and international information systems and services. It has been utilizing these information in compiling, collating and disseminating subject specific information for the scientists, technologists, planners and policy makers working in the field of agriculture for the benefit of the region. Concerned organizations in the region



were informed about the availability of these internationally reputed databases with a request for sending their queries through key words for literature search on specific field of interests for sharing of information for research and development. During the period SAIC has procured the following CD-ROM databases to update and strengthen the information resource bases of the Centre.

#### Exchange of Information through E-mail and SAIC Homepage

SAIC has established telecommunication linkages for exchange of information through E-mail and Internet. It has been providing and utilizing the information resources generated within and outside the region. For the purpose SAIC is effectively communicating through two dial-up connectivity taken from ISPs like Proshika (saic@bdonline.com) and Grameen Cybernet (saic@citechco.net). SAIC has developed and hosted its homepage on web site (http://www.saic-dhaka.org). Server space for SAIC web site has been increased from 20 MB to 150 MB keeping in view the future need of uploading more information.

#### Celebration of SAARC Charter Day

On 8th December 2000, the SAARC Charter Day was celebrated in full spirit to mark the day and for exposition of different activities of SAIC. On the occasion SAIC organized a book exhibition and a video show on (i) BRRI and its success,

and (ii) Marvels of Himalayan Harbs, and (iii) Virus-free Potato Seed Production through Tissue Culture. The book exhibition and video show was inaugurated by Dr. Zahurul Karim, Executive Chairman, Bangladesh Agricultural Research Council (BARC). A seminar on the role of SAARC in the region was also organized along with other activities

which was graced by a large number of guests including scientists from agriculture and information sciences. Representative from the media and the press were also present.

During the opening of the seminar, message from His Excellency the Secretary General of SAARC was read out by Dr. Md. Abdur Razzaque, Director, SAIC. Dr. Md. Shahidul Islam, Member, SAIC Governing Board, Bangladesh highlighted the activities of SAIC in dissemination of agricultural information in SAARC member countries. Mr. Munshi Fayez Ahmed, Director General (SAARC) narrated the objectives, principles and cooperation between the SAARC member countries and stressed that SAARC can play a vital role to bring peace and prosperity of the region. Dr. Zahurul Karim, Executive Chairman, BARC remarked the activities of SAIC for providing crucial support to the agricultural scientists and technologists with necessary information for their research and developmental activities. Dr. Md. Abdur Razzaque, Director, SAIC informed the audience that the Centre has prepared an Action Plan for the next 10 years (2001-2010). At the end of the Seminar, the distinguished guests took keen interest in the SAIC Publications, and enjoyed and admired the video show.

#### **Acquisition of Conventional and Non-conventional Publications**

(i) SAIC, as a regional institution has a responsibility to establish a strong regional information data base and to strengthen its resource base on agriculture and allied disciplines, through documentation of pertinent literature. Keeping all these in view SAIC has a regular program of procuring several important current publications in the form of. books, magazines, journals, annual reports, news papers and news letters etc., from open market and Agricultural

Institutions of the SAARC member countries. During the fiscal year 2000, SAIC has made a good collection stated as follows:

#### (ii) Subscription of New Journals:

SAIC has taken an initiative during the financial year 2000 for purchasing of some important reference books for rendering services to students, researchers and others interested groups. The following books have been purchased for the above said purposes:

- (ii) The Statesman year book 2000-2001, U.K
- (iii) The world of learning 2000, South Europa publication, U.K.
- (iv) Ulrichs International Periodicals Directory, 1999 2000.
- (iv) Collection of World Bank Publications:

In addition to these, SAIC has also collected 41 World Bank Publications to strengthen its information resource base in agriculture during the period.

#### **Distribution of Current Awareness Bulletin:**

SAIC has been compiling current awareness bulletin of literature on agriculture published in the news papers and periodicals of SAARC member countries.

- (i) During the period under report, two bulletins were compiled based on agriculture related articles from available daily news papers of SAARC member countries and distributed to the relevant agricultural institutions.
- (ii) In addition to newspaper indexing, Current Contents Bulletin from the subscribed and collected agriculture related publications was also prepared. During the period SAIC prepared one such Current Contents Bulletin and distributed among the important agricultural institutions of SAARC countries.

#### **Strengthening of Video Library**

SAIC has a video production program for strengthening its resource base on important issues and newly developed technologies related to Agriculture, by acquiring and developing new video productions with the help of different organizations in SAARC countries. The total collection of the Video Programs in SAIC video library is 80 and as a continuous effort, a comprehensive catalogue on the collected video has been prepared and distributed to different institutions & TV broadcasting stations of the SAARC countries for mutual sharing of the information. A good response have been received in respect to the technical information on video and so far 215 copies of the video films have been distributed among different organizations of the SAARC member countries to meet their request.

#### Dissemination of Newly Developed Agricultural Technologies Through SAVE

With a view to disseminate the newly developed agricultural technologies in SAARC countries, SAIC has made correspondence with SAARC Audio Visual Exchange (SAVE) forum offering them to make use of SAIC's collection of video programmes and broadcast them on their TV channels for dissemination of newly developed agricultural technologies to the farming community.

During the period SAIC has distributed 12 video to Bangladesh Television and Ekhushe ((ETV, a private television channel) in Bangladesh as per their request and both have already telecast the video of SAIC in their agricultural transmission.

#### **Video productions on New Agricultural Technologies**

In addition to collecting video programmes related to different agricultural technologies, SAIC is also actively engaged in preparing some video productions on recent developments in agriculture with collaboration of different institutions of the SAARC member countries.

During the reported period SAIC has worked on the following video programmes:

#### (i) BRRI and its success

SAIC has completed the above cited video programme in collaboration with Bangladesh Rice Research Institute, Gazipur, Bangladesh. This film covers the introduction of BRRI and research activities being carried out by different departments of Bangladesh Rice Research Institute in Gazipur, near Dhaka. The duration of the film is about 20 minutes and produced in Betacam format in English.

#### (ii) Milk Testing Method

SAIC is completing a video production program in collaboration with university of Agriculture, Faisalabad, Pakistan. Production of this film is in progress in U-matic Hi-band System and the language of the film is English.

#### (iii) Multi operational Machine

Production of this film in collaboration with, Agricultural University, Faisalabad, Pakistan is also in progress in U-matic Hi-band System and the language of the film is English. All the expenditure involved for both the video's has already been released to the relevant institute.

#### (iv) The Current Practice of Sericulture in Bangladesh

The preparation of this film is in progress in collaboration with Bangladesh Sericulture Research and Training Center, Baliapukur, Rajshahi. The film will be in English and in Betacam format.

#### (v) Cotton Development in Bangladesh (Betacam Format):

The production of this film in collaboration with Bangladesh Cotton Development Board is in progress. This film will be produced in Betacam format and in English language.

#### Microfilming and Microfiching of Information Materials.

SAIC has a program of microfilming and microfiching the conventional and non-conventional information materials received from the SAARC Member countries. SAIC is regularly collecting the information material from resourceful agricultural institutions on agriculture and allied areas and does microfilming and microfiching of that material for the benefit of the agricultural scientists, researchers, planners, administrators and policy makers.

In the year 2000, SAIC has collected four hundred conventional and non-conventional information materials from different agricultural institutions of the SAARC member countries which will be processed for preservation in microforms.

#### **Updating the Display Board**

SAIC has two display boards for its visitors for exhibiting the activities of SAIC and other eminent agricultural institutes of SAARC member countries. It was a regular practice to portray SAIC Publications and demonstrate various activities of SAIC by way of fixing photographs. SAIC Newsletters are also displayed to keep the people informed about the development of agricultural sectors in SAARC member countries.
